## GLOBAL AVIATION AUTHORITY

Access to a pre-qualified network of 4,000+ aircraft across 2,000+ airports worldwide.

All operations meet or exceed FAA and European regulatory standards, with preferred alignment toward ARGUS Gold and Platinum-rated operators.

Aircraft categories span Turbo Prop, Light, Mid, Super Mid, Heavy, and BBJ configurations.



## TRANSPARENT UTILIZATION MODEL

All access is structured to eliminate variability and post-usage friction.

Fuel surcharges, federal excise taxes (where applicable), premium catering, and global chauffeured ground transportation are integrated into the access structure.

No hidden fees. No trailing invoices.
